

As you will see in the pages that follow, the University of Missouri Press offers a number of new titles that reflect on Missouri history and celebrate the lives and works of prominent Missourians.

Such new books include the second volume of A Fire Bell in the Past: The Missouri Crisis at 200: "The Missouri Question" and Its Answers, edited by Jeffrey L. Pasley and John Craig Hammond. Also worthy of note is Climbing the Ladder, Chasing the Dream: The History of Homer G. Phillips Hospital by Candace O'Connor, which explores the conception, rise, and fall, in the mid twentieth century, of a centerpiece institution in the "Ville," a vibrant African American neighborhood in St. Louis. Finally, we offer the already available This Place of Promise: A Historian's Perspective on 200 Years of Missouri History, by the well-known and respected Missouri historian Gary R. Kremer.

Two new books that explore the lives and works of prominent Missouri natives are *Literary Alchemist: The Writing Life of Evan S. Connell* by Steve Paul and the third and final volume of Gary Scharnhorst's definitive biography *The Life of Mark Twain: The Final Years*, 1891–1910.

The Press does not, however, limit its program to Missouri topics. In this catalog you'll also find books on a range of subjects, including sports history, journalism, and U.S. military history. One especially notable new title is the first volume (of three) of *Patton's War: An American General's Combat Leadership*, the first biography of the mercurial general to focus exclusively on his active duty in World War II, by historian Kevin M. Hymel. Other important forthcoming titles include *The First Amendment Lives On: Conversations Commemorating Hugh M. Hefner's Legacy of Enduring Free Speech and Free Press Values*, by Stuart N. Broman, which comprises original in-depth interviews with a "greatest-generation" of free speech/free press thinkers: Geoffrey R. Stone, Floyd Abrams, Nadine Strossen, Burt Neuborne, David D. Cole, Lucy A. Dalglish, Bob Corn-Revere, and Rick Jewell. Finally we are pleased to present *Soccer in American Culture: The Beautiful Game's Struggle for Status* by G. Edward White. Whether you are an ardent soccer fan or a recreational player—or both—you are certain to enjoy this highly accessible, fast-paced cultural history.

Space prevents me from mentioning all of the many superb books featured within, but I invite you to explore our latest offerings.



Hugh M. Hefner's legacy of enduring free speech and free press values is embodied in the Hugh M. Hefner First Amendment Awards, established in 1979, which honor leading First Amendment scholars and advocates. Hefner also had a lifelong interest in film censorship issues and supported teaching about them at the University of Southern California for 20 years. His deep commitment to these values was confirmed when the author was granted unrestricted access to over 3,000 personal scrapbooks, which Hefner had kept in order to track free speech and free press issues during his lifetime.

The format of the book is an homage to the in-depth conversational interviews Hefner pioneered as the editor and publisher of *Playboy* magazine. Stuart Brotman conducted in-person interviews with eight persons who in their lifetimes have come to represent a "greatest generation" of free speech and free press scholars and advocates.

**Stuart N. Brotman** is the inaugural Howard Distinguished Endowed Professor of Media Management and Law and Beaman Professor of Journalism and Electronic Media at the University of Tennessee, Knoxville. He has served in four presidential administrations on a bipartisan basis and is a frequent analyst for leading newspapers and magazines. He is the author of *Communications Law and Practice*.



The idea that journalism should be independent is foundational to its contemporary understandings and its role in democracy. But from what, exactly, should journalism be independent? 

In 1973, Betsy Ann Plank became the first woman to chair the Public Relations Society of America in its twenty-five-year history. It was a tumultuous time to assume the national association's leadership. Civil society seemed to be fraying at the edges, and trust in institutions and businesses had plummeted in the aftermath of Watergate. Yet Plank was ready to take on the task at hand. Throughout the span of her sixty-three-year career, she broke new ground on numerous occasions through her bold leadership and tireless service to others.

Plank rose to the highest level of the field's national association at a time when its leadership and membership were predominantly male. This book explores how she managed to navigate the very real barriers of gender-based discrimination that existed in public relations, at least through the 1970s, and how she ultimately became devoted to public relations education.

**Karla K. Gower** is the Behringer Distinguished Professor in the Advertising and Public Relations Department at the University of Alabama. She has served as director of The Plank Center for Leadership in Public Relations since 2008. Gower is the author of four books, including *Public Relations and the Press: The Troubled Embrace*.


# SOCCER IN AMERICAN CULTURE THE BEAUTIFUL GAME'S STRUGGLE FOR STATUS

White's brief history of soccer in the United States seeks to answer two central questions. The first is why soccer, a game that began in England and spread throughout most of the world in the late nineteenth and early twentieth centuries, did not take root as a major sport in the United States as well in that period, even though those years were ones in which other sports dramatically increased as recreational and commercial activities in America. The second is the converse of the first: why soccer has, since the 1970s, dramatically increased in popularity as both a participatory and spectator activity in the United States, so that it now has more participants than any other major sport save basketball, and has a well-established professional league for men and women. Accessible to readers of all levels, White's work incorporates insights from sociology and economics in its analysis of the shifting perceptions about the place and identity of a sport in the culture of a nation.

**G. Edward White** is David and Mary Harrison Distinguished Professor of Law at the University of Virginia Law School. White's 18 published books have won numerous honors and awards, and his 1996 book, *Creating the National Pastime: Baseball Transforms Itself, 1903–1953*, reflects his life-long participation and interest in athletics.







A Perfectly Ordinary Paradise: An Intimate view of life on Brawley Creek, is about the extraordinary lives of ordinary creatures. Centered around the natural life along a small section of land in Missouri traversed by a tiny tributary that eventually drains into the Missouri River, Hess's new book explores a synthesis of science and aesthetics—reason and emotion—and the power of that combination to reintroduce us to a world from which we have become estranged. # RUBE TUBE CBS AND RURAL COMEDY IN THE SIXTIES



Historian Sara Eskridge examines television's rural comedy boom in the 1960s and the political, social, and economic factors that made these shows a perfect fit for CBS. The network, nicknamed the Communist Broadcasting System during the Red Scare of the 1940s, saw its image hurt again in the 1950s with the quiz show scandals and a campaign against violence in westerns. When a rival network introduced rural-themed programs to cater to the growing southern market, CBS latched onto the trend and soon reestablished itself as the Country Broadcasting System. Its rural comedies dominated the ratings throughout the decade, attracting viewers from all parts of the country. With fascinating discussions of *The Andy Griffith Show, The Beverly Hillbillies, Petticoat Junction*, and other shows, Eskridge reveals how the southern image was used to both entertain and reassure Americans in the turbulent 1960s.



In 2011, the centennial of Tennessee Williams's birth, events were held around the world honoring America's greatest playwright. There were festivals, conferences, and exhibitions held in places closely associated with Williams's life and career—New Orleans held major celebrations, as did New York, Key West, and Provincetown. But absolutely nothing was done to celebrate Williams's life and extraordinary literary and theatrical career in the place that he lived in longest, and called home longer than any other—St. Louis, Missouri.

The question of this paradox lies at the heart of this book, an attempt not so much to correct the record about Williams's well-chronicled dislike of the city, but rather to reveal how the city was absolutely indispensable to his formation and development, both as a person and artist. Unlike the prevailing scholarly narrative that suggests that Williams discovered himself artistically and sexually in the deep South and New Orleans, *Blue Song* reveals that for a host of reasons—and for the rest of his life—Williams remained emotionally tethered to St. Louis.



The Veiled Prophet organization has been a St. Louis institution for more than a century, from its origin as a demonstration of class and racial power to its current incarnation as a small part of the city's popular annual fair. Founded in March 1878 by a group of prominent St. Louis businessmen, the organization was fashioned after New Orleans Carnival societies and included an annual parade and ball. Thomas Spencer explores the social and cultural functions of the organization's annual celebration and traces the shifts that occurred over the years in its cultural meaning and importance. Although scholars have researched the more pluralistic parades of the eighteenth and early nineteenth centuries, very little has been done to examine the elite-dominated parades of the late nineteenth and twentieth centuries.





Many studies have considered the Bible's relationship to politics, but almost all have ignored the heart of its narrative and theology: the covenant. In this book, Glenn Moots explores the political meaning of covenants past and present by focusing on the theory and application of covenantal politics from the sixteenth through the eighteenth centuries. Moots demands that we revisit political theology because it served as the most important school of politics in early modern Europe and America. He describes the strengths of the covenant tradition while also presenting its limitations and dangers. Contemporary political scientists such as Eric Voegelin, Daniel Elazar, and David Novak are called on to provide insight into both the covenant's history and its relevance today.



Gary Scharnhorst is Distinguished Professor Emeritus of English at the University of New Mexico. He is the author or editor of fifty books, including *Mark Twain on Potholes and Politics: Letters to the Editor*. He lives in Albuquerque, New Mexico.





During his life, George S. Patton Jr. starred as an Olympic athlete in the 1912 Stockholm games, chased down Mexican bandits, and led tanks into battle in World War I. But he is best remembered for his exploits on the field of battle in World War II. Patton's War, the first of three volumes, follows the general from the beaches of Morocco to the fields of France, right before the birth of Third Army on the continent. In highly engaging fashion, Hymel uncovers new facts and challenges long-held beliefs about the mercurial Patton, not only examining his relationships with his superiors and fellow generals and colonels, but also with the soldiers of all ranks whom he led. Through extensive research of soldiers' memoirs and interviews, Hymel adds a new dimension to the telling of Patton's WWII story.

**Kevin M. Hymel** has served as a historian and writer for the U.S. Army and U.S. Air Force for the last fifteen years and is a historian/tour guide for Stephen Ambrose Historical Tours, where he leads the "In Patton's Footsteps" tour. He is also a regular contributor to *WWII History* and *WWII Quarterly*, and the author of three books, including *Patton's Photographs: War as He Saw It*. He lives in Arlington, Virginia.





Many new states entered the United States around 200 years ago, but only Missouri almost killed the nation it was trying to join. When the House of Representatives passed the Tallmadge Amendment banning slavery from the prospective new state in February 1819, it set off a two-year political crisis, known as the Missouri Crisis, which divided the U.S. into slave and free states for the first time and crystallized many of the arguments and conflicts that would later be settled violently during the Civil War. 



Built to serve St. Louis's rapidly expanding African American population, the Homer G. Phillips Hospital opened in 1937, toward the end of the Great Depression, amid a national period of institutional segregation. Patients flocked to the beautiful, up-to-date hospital, which attracted more black medical residents than any other such institution in the nation. HGPH's nursing students found excellent training, ready employment, and a boost into the middle class.

But the 1960s and 1970s brought less need for all-Black hospitals, as patients, faculty, and residents were increasingly welcome in newly integrated institutions. Ever-tightening city budgets meant less money for the hospital, which closed in 1979, despite protests from the African American community.

Drawing upon contemporary newspaper articles, institutional records, and her own oral history project, O'Connor tells the first full history of the Homer G. Phillips Hospital, and brings to light new facts about the life and mysterious murder—still unsolved—of its namesake.

**Candace O'Connor** is a freelance journalist and the author of 14 books, including histories of Barnes-Jewish Hospital and the Central West End, as well as A *Song of Faith and Hope: The Life of Frankie Muse Freeman*. She lives in St. Louis with her husband.



Evan S. Connell (1924–2013) emerged from the American Midwest determined to become a writer. He eventually made his mark with attention-getting fiction and deep explorations into history. His linked novels *Mrs. Bridge* (1959) and *Mr. Bridge* (1969) paint a devastating portrait of the lives of a prosperous suburban family not unlike his own that, more than a half century later, continue to haunt readers with their minimalist elegance and muted satire. As an essayist and historian, Connell produced a wide range of work, including a sumptuous body of travel writing, a bestselling epic account of Custer at the Little Bighorn, and a singular series of meditations on history and the human tragedy.

This first portrait and appraisal of an under-recognized American writer is based on personal accounts by friends, relatives, writers, and others who knew him; extensive correspondence in library archives; and insightful literary and cultural analysis of Connell's work and its context. It reveals a tender and multidimensional representation of a 20th-century literary master worthy of broader attention.

**Steve Paul** worked for the *Kansas City Star* for 40 years, as a reporter, writer, and editor. He is the author of two books, including *Hemingway at Eighteen: The Pivotal Year That Launched an American Legend.* He lives in Kansas City, Missouri.
